

## Limited Marketing Campaign Indonesia

### Terms & Conditions

We would like to offer you some additional benefits to improve your Paysend experience on the terms provided in these Limited Marketing Campaign – Indonesia Terms & Conditions.

#### 1. Program

- 1.1 The Program will start at 13:00:00 GMT on the 1<sup>st</sup> of June 2021 and will end at 23:59:59 GMT on the 30<sup>th</sup> of June 2021 inclusive (“**Term**”).
- 1.2 If you as an eligible customer complete at least one successful international transfer to Indonesia, if the amount of such transfer equals to or exceeds IDR 50 000 (Fifty Thousand Indonesian rupiah), within the Term (“**Eligible Transaction**”), and Paysend does not deliver funds to the recipient within Sixty (60) minutes from the moment of the visual confirmation that the transaction is sent.
- 1.3 You will be able to receive the equivalent of IDR 50 000 (Fifty Thousand Indonesian rupiah) (**Reward**) in your local currency to the balance of your bonus account on or before July 10, 2021.
- 1.4 You must notify us in writing within three (3) days if the Eligible Transaction was not sent within sixty (60) mins and wish to claim your bonus.
- 1.5 For the avoidance of doubt, only successful Eligible Transaction will qualify. Each customer can benefit from the Program only once during the Term.

#### 2. Customer’s Eligibility

- 3.2 The relationship between You and Paysend plc shall be governed by this Amendment with respect to the matters specifically provided herein and by the Agreement with respect to any other matters. This Amendment sets out the terms and conditions of a marketing campaign (“**Program**”) launched by Paysend plc (“**Paysend**”), and any transaction initiated by You within the term of the Program will be governed by this Amendment. If You do not agree or do not accept this Amendment, you must not use Paysend service for completing payment transactions.
- 3.3 Unless otherwise provided by this Amendment, all capitalized terms shall have the meaning prescribed to them in the Agreement.
- 3.5 The Reward’s denomination currency will be determined by Paysend in its sole discretion and will in most cases be the same as the Eligible Transaction originating currency. You will not be able to choose the Reward’s denomination currency.
- 3.6 All Eligible Transactions are non-refundable.
