## Terms & Conditions Campaign ( November 2021) China / Alipay

- 1.General
- 1.1 These Limited Marketing Campaign Terms & Conditions China (this "Amendment") are an integral part of the general PAYSEND PLC TERMS OF SERVICE available at <a href="https://paysend.com/docs/paysend-plc-term-en.pdf">https://paysend.com/docs/paysend-plc-term-en.pdf</a> (the "Agreement").
- 1.2 The relationship between You and Paysend plc shall be governed by this Amendment with respect to the matters specifically provided herein and by the Agreement with respect to any other matters.
