

**Limited Marketing Campaign
Terms & Conditions
China / Alipay**

- General
 - These Limited Marketing Campaign Terms & Conditions - China (this “**Amendment**”) are an integral part of the general **PAYSEND PLC TERMS OF SERVICE** available at https://paysend.com/docs/paysend_plc_term_en.pdf (the “**Agreement**”).
 - The relationship between You and Paysend plc shall be governed by this Amendment with respect to the matters specifically provided herein and by the Agreement with respect to any other matters. This Amendment sets out the terms and conditions of a marketing campaign (“**Program**”) launched by Paysend plc (“**Paysend**”), and any transaction initiated by You within the term of the Program will be governed by this Amendment. If You do not agree or do not accept this Amendment, you must not use Paysend service for completing payment transactions.
 - Unless otherwise provided by this Amendment, all capitalized terms shall have the meaning prescribed to them in the Agreement.
- Program
 - 2.1. The Program will start at 0000hrs (Beijing Time) on the 7th of June 2021 and will end at 23:59:59 Beijing Time on the 17th of June 2021 inclusive (“**Term**”).
 - 2.1.1 Within the Term, you will have a right to receive rewards (each – “**Reward**”) for completing successful transactions as follows:
 - 2.1.2 All applicable transfers under this Program are fee free during the specified Term, subject to a customer’s eligibility
 - 2.1.3 This Program is applicable to each Paysend customer from a relevant corridor that registers as a customer during the Term or is an existing customer and either have not yet at the commencement of the Term sent funds to an Alipay user in China previously and sends specified funds to an Alipay user in China during the Term. The customer will then receive a specified bonus for their first successful transfer of funds
- a Paysend customer from RU/ Kazakhstan corridor that registers during the Term and has not yet at the commencement of the Term sends funds to China to an Alipay user previously will receive a bonus in the equivalent of 120 (one hundred and twenty) Chinese Yuan (CNY) for the first successful money transfer in the amount of 6,000 (six thousand) Chinese Yuan or more to China to an Alipay user (“**Eligible Transaction**”)
- a Paysend customer from EEA and US/ Canada corridor that registers during the Term and has not yet at the commencement of the Term sends funds to China to an Alipay user previously will receive a bonus in the equivalent of 120 (one hundred and twenty) Chinese Yuan (CNY) for the first successful money transfer in the amount of 3,000 (three thousand) Chinese Yuan or more to China to an Alipay user (“**Eligible Transaction**”)
- a Paysend customer from UK corridor that registers during the Term and has not yet at the commencement of the Term sends funds to China to an Alipay user previously will receive a bonus in the equivalent of 120 (one hundred and twenty) Chinese Yuan (CNY) for the first successful money transfer in the amount of 4,000 (four thousand) Chinese Yuan or more to China to an Alipay user (“**Eligible Transaction**”)
- 2.2 For the avoidance of doubt, only the first successful transaction completed within the Term are eligible to receive the specified Reward, provided that the amount of each transaction will be equal to or exceed the amount specified or its equivalent in the foreign currency. Each Paysend Customer can benefit from the Program only once for the entire Term.
- 2.3 The Reward’s denomination currency will be determined by Paysend in its sole discretion and will in most cases be the same as the Eligible Transaction originating currency. You will not be able to choose the Reward’s denomination currency.
- 2.4 All Eligible Transactions (as any other transfer using Paysend service) are non-refundable.

- Customer's Eligibility

You are authorized to participate in the Program if:

- You have not completed any transactions to Alipay China account prior to the first day of the Term; and
- You have not claimed a refund on the completed Eligible Transaction.
