

## **PAYSEND WECONNECT OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

**PROMOTION DESCRIPTION:** The Paysend WeConnect Sweepstakes begins on September 7th, 2021 at 9:00 a.m. EDT TIME and ends on September 30th, 2021 at 5pm EDT (the "Promotion Period").

The sponsor of this Sweepstakes is Paysend US LLC ("Sponsor").
